RULES AND REGULATIONS

The Garden is owned and operated by:

Wyangala Country Club Ltd ABN: 38 001 011 507.

Its purpose be a peaceful and serene setting that provides a physical location for families and friends to visit and reflect on their loss.

As we strive to maintain high standards of beauty, peace and tranquility in the Garden. The following Rules and Regulations (the "Rules") are designed to support this objective as well as seeking to protect the safety of all those that visit and work in the Garden.

- Garden Access All memorial requests are to be approved by the Board of the Club. Requests must be in writing and include proposed location and design of the memorial. The Club will not bear any costs associated with any memorial with the exception of general garden maintenance.
- 2. Prohibited items We may refuse, rectify orremove any ornamentation or changes to a Memorial or Site. For example, we will not allow and will remove items such as artificial flowers, statues, permanent wreaths or floral sprays, boxes, shells, glass and toys and anything that we consider detracts from the beauty ofthe Garden or is a safety hazard, or is in conflict with these Rules.
- Human Remains This is a memory garden only, no human remains are to be buried or scattered within the Garden.
- 4. Fresh Flowers Fresh flowers may be placed near the Memorial on special occasions (including, but not limited to, the anniversary date, birth date, Mother's Day, Father's Day, Christmas). It is at the Clubs discretion when these flowers will be removed when no longer considered fresh. For the purpose of clarity no vases or jars are permitted.
- 5. Monuments Monumental Structures are not permitted. Sites can be marked with a small plaque not greater in size than the paver supplied by the Club. Families wishing to plant a tree/shrub/flower must gain prior approval and provide relevant details of proposed variety that takes into consideration suitability to this site and environment. The Club will not be held

responsible for the watering or survival of any tree/shrub/flower.

- Removal of trees If any tree or shrub in the Garden or on a site becomes dangerous, detrimental, unsightly or annoying, we may remove it, or any part of it.
- Landscape Landscaping is our responsibility. We have complete discretionin relation to decisions on landscaping and any other building or structures in the Garden. No person may plant, place or remove any grass, shrub, tree or any other structure without our prior consent.
- Alterations For reasons of beauty, maintenance and safety of the Garden, we and only we may realign or alter the position of memorials spaces (including lifting and levelling of plaques).
- Events From time to time (with permission) we may allow cultural, religious or other events to be heldin any area of the Garden.
- Removal of people from the Garden -Any person engaging in offensive, inappropriateor improper conduct may be removed from the Garden.
- Children Children must be properly supervised at all times. Unaccompaniedchildren are not permitted in the Garden.
- 12. Safety While we take all reasonable care for the safety of visitors to the Garden and their belongings, it is the responsibility of those visitors to ensure their own safety and the protection of their possessions. The Club is not liable for personal injury, property damageor theft that occurs within the Garden unless solely caused by the gross negligence or willfulmisconduct of our employees or agents.
- 13. Images of the Garden We can use for any lawful purpose, including online, any visual representations (such as photographs, drawings, maps, film or video) of any portion of the Garden, including memorials.
- Garden development We may at any time alter or change any feature (including plants), improvement or structure of the

Garden.

15. Changes to Rules and Regulations - In theinterest of protecting our high standards ofbeauty, peace and tranquility, these Rules and Regulations may be subject to change.
